Attorney-General Jarrod Bleijie said Johnson, who is charged with five counts of sexual assault, would not be subject to home detention. Court documents say the 31-year-old, who now fights out of New South Wales, has displayed behavioural issues and threatened to hit police, judges and his own lawyers. Mr Bleijie said the public was at 'great risk' if Johnson was bailed and put under house arrest. Anthony 'Rumble' Johnson, 31, will appear in the Burwood Local Court today Anthony Johnson is now facing court for a fourth time. Trevor Nowak had his bail conditions relaxed in June after he told authorities his home was not secure and he worried about his safety. Mr Nowak's wife, with whom he has two young children, said she did not think her husband was a threat and wouldn't have a problem if he was released on bail. Last month, the Burwood Local Court heard Mr Nowak was due to compete in a cage fight on August 3 but was likely to be arrested before that date. Johnson's last fight was against Tom Lawlor in March, where he received a TKO after landing punches. After the bout, he claimed he wanted to retire and had been spending a lot of time at a gym. The Burwood Local Court heard on July 5 that Johnson's bail conditions have been tightened after he failed to attend bail review. "The public is at great risk if Mr Johnson is released on bail and put under house arrest," Mr Bleijie said. "From the

outset I have advised the court that if there were issues around bail release that it would need to be properly assessed. "Now, having given this assessment, I can advise
